

## **FLORIDA DAIRY FARMERS '40 PRIZES FOR 40 YEARS' SUMMER SWEEPSTAKES OFFICIAL RULES**

**PLEASE REVIEW THE "DISPUTES" PARAGRAPH IN THESE OFFICIAL RULES REGARDING YOUR RIGHTS IN ANY DISPUTE INVOLVING THIS PROMOTION, INCLUDING A MANDATORY ARBITRATION CLAUSE AND A WAIVER OF A JURY TRIAL OR CLASS ACTION, THAT LIMITS YOUR RELIEF.**
